## **Ex-Prosecutor Joins Crowell & Moring Cybersecurity Team**

Jennie Wang VonCannon, who spent three years at Ellis George and 11 years before that as a federal prosecutor, joins the Crowell & Moring's white collar and regulatory enforcement and privacy and cybersecurity groups. She defends clients in white collar matters, handles business and commercial civil litigation, and advises on cybersecurity issues.

"I was initially drawn to Crowell's dynamic platform in both the white collar and von cyber spaces, but was really sold by its standout collegial culture," VonCannon said in a statement. "I am thrilled to grow my practice at a firm with so much to offer my clients."

VonCannon earned her law degree in 2004 from the University of California, Berkeley School of Law. She worked as an associate with Quinn Emanuel Urquhart & Sullivan LLP for 3½ years.

In 2008, she joined the U.S. Department of Justice in the Central District of California. During her 11-year tenure there, she was appointed deputy chief of the Cyber and Intellectual Property Crimes section of the National Security Division.

In 2019, VonCannon joined Ellis George, which was then known as Browne George Ross O'Brien Annaguey & Ellis LLP.

She was on the team that represented a U.S. Army Special Forces veteran contending he was owed more than \$1 million for his work on a failed cannabis venture in a 2020 suit against a Russian oligarch.

And in late 2021, VonCannon was on the team the that got a full acquittal for a doctor charged with 33 counts of health care fraud related to his use of lap band surgery.
