"It's rare to have a pretty strong antitrust presence in Orange County, but it's a practice that we've really been able to develop because we've been able to do both sides," Solh told the *Daily Journal*.

Outside of the courtroom, Solh serves as co-chair of the American Bar Association Young Lawyers Division's Antitrust Law Committee. Additionally, she volunteers with the Public Law Center handling pro bono immigration cases, including helping a sexual abuse victim report the crimes to police and earn permanent legal status.
