His practice focuses on all aspects of compliance with U.S. economic sanctions, including day-to-day compliance guidance, developing compliance programs, responding to government inquiries, conducting internal investigations, and representation during civil and criminal enforcement proceedings. *American Lawyer* recognized him for his role working with clients on a daily basis to manage complying with international sanctions, particularly in the wake of Russia’s invasion of Ukraine.
