Focused on government investigations, independent monitorships and trial advocacy on behalf of corporate and individual clients, Ricigliano is a member of the Federal Bar Council's Inn of Court, where she mentors young attorneys, and is the recipient of the True American Hero Award from the Federal Drug Agents Foundation and of the Investigations Award for Excellence from the Council of the Inspectors General on Integrity and Efficiency.
