Hub Hires: Nixon Peabody, Prince Lobel, Manatt

Law360 (October 2, 2023, 6:04 PM EDT) -- The start of fall brought a flurry of moves in Boston's legal scene, with Nixon Peabody making a pair of additions, Prince Lobel boosting its employment practice and Manatt adding a former unit chief from the state attorney general's office.

Here are the latest hires in the Hub.

Nixon Peabody

Nixon Peabody LLP hired in-house veteran William Connolly as the law firm's new general counsel and chief legal officer following Connolly's more than a decade as head of litigation at State Street Bank and Trust Co.

In a statement, the firm said that Connolly's background will help the firm's clients navigate complex legal and business risks.

"Bill's proactive approach to risk management will help ensure we provide clients with the highest quality service to achieve their goals," said Stephen Zubiago, Nixon Peabody CEO and managing partner, in a statement. "As we evolve our Office of General Counsel to support current and future needs of the firm, Bill's diverse range of experience is a significant asset."

Nixon also brought in Kristen Fallon, an attorney known for representing real estate investment trusts and financial institutions.

Fallon was most recently a partner at Riemer & Braunstein LLP, and the firm said she will continue her work on sophisticated real estate finance transactions for developments, portfolio lending, construction loans and restructurings.

Fallon told Law360 that the move to Nixon Peabody would let her continue growing her national practice.

"I look forward to serving existing clients and expanding my practice by advising lenders on a wide range of transactions in the REIT and fund finance space," Fallon said in an email to Law360.

Prince Lobel

Prince Lobel Tye LLP announced Justin Engel, most recently an attorney with Armstrong Teasdale LLP, has joined the firm as a partner in the employment law and business litigation practice groups in the Boston office.

Manatt

Nutter
