Former Crowell & Moring Partner Rejoins Firm From Paradigm

Richard Holbrook rejoins Crowell & Moring's corporate group to continue his work focused on corporate joint ventures and investing matters, like those associated with investment funds or with cross-border transactions. He rejoins the firm from Paradigm, a financial services company that works with crypto derivatives traders, where he was the

company's general counsel and chief legal officer based in Singapore.

Paradigm is one of Crowell & Moring's technology clients, according to the firm's statement on Monday.

Holbrook first joined Crowell & Moring in 2004, the firm said. Before joining Cleary, Holbrook clerked for U.S. Circuit Judge Emilio M. Garza on the Fifth Circuit.

Samuel E. Feigin, chairman of the firm's corporate group, said in a statement that Holbrook's versatility and professional proficiency in several areas of corporate law over his career would be invaluable to the firm's clients.
