# **Beltway Moves: Norton Rose, Paul Hastings, IRS**

Law360 (March 8, 2024, 4:04 PM EST) -- Antitrust and the life sciences were areas of focus in the Washington, D.C., legal market in recent weeks, with team leadership hires made by firms such as Norton Rose Fulbright, Paul Hastings LLP and Crowell & Moring International LLC.

Meanwhile, the U.S. Senate confirmed the first woman to be chief counsel at the Internal Revenue Service, and a former top aide to Sen. Peter Welch, D-Vt., headed to Cozen O'Connor Public Strategies.

Here are the latest legal hiring developments in the nation's capital.

### Winston & Strawn Atty Returns to Norton Rose as Antitrust Lead

Norton Rose Fulbright announced Tuesday that Neely Agin rejoined the firm to serve as the U.S. head of its antitrust practice.

Agin had been with Winston & Strawn LLP for six years and previously was with Norton Rose for more than two decades.

She guides companies through merger review and clearance processes, and other antitrust investigations by the U.S. Department of Justice and Federal Trade Commission, and has extensive experience working on an array of antitrust issues in the retail, energy and healthcare sectors.

#### Paul Hastings Adds FDA Practice Chair From King & Spalding

Paul Hastings LLP announced Feb. 26 it brought on Eva Temkin from King & Spalding LLP to chair its new U.S. Food and Drug Administration practice.

Temkin, who had been with King & Spalding for three years, held a variety of roles at the FDA from 2017 to 2021.

She led policy development at the agency relating to biological products as director of policy for the Office of Therapeutic Biologics and Biosimilars. She also served as associate chief counsel at the FDA's Office of Chief Counsel.

## Paul Hastings Hires 6-Partner IP Team from Allen & Overy

Paul Hastings LLP also hired a litigation team from Allen & Overy LLP to boost the firm's intellectual property practice, including some based in D.C., the firm said Monday.

The Washington lawyers are Shamita Etienne-Cummings and James Gagen. A firm spokesperson said an additional D.C.-based attorney will be named once they've officially left Allen & Overy.

Also joining the firm were Lisa Nguyen and Eric Lancaster in Palo Alto, California, and Grace Wang in New York.

The group works across Big Tech and related industries, including artificial intelligence, e-commerce, software and hardware systems, internet, telecommunications, mobile devices, consumer electronics, and payment systems.

#### **Senate Confirms First Woman To Top IRS Attorney Post**

The U.S. Senate on Feb. 29 confirmed Marjorie Rollinson to be chief counsel at the Internal Revenue Service, making her the first woman to be confirmed for the role.

President Joe Biden nominated Rollinson for the post in June, and the Senate approved her confirmation by a vote of 56-41.

Rollinson most recently worked as the deputy director of the national tax department at EY, formerly known as Ernst & Young. She previously worked for the IRS from 2013 until 2019, and was named associate chief counsel international in 2016.

She was sworn into her new position Wednesday. As part of her chief counsel role, she will also serve as assistant general counsel at the U.S. Department of the Treasury. The IRS chief counsel's office has about 2,600 employees.

# Cozen O'Connor Adds Welch Aide To Gov't Affairs Team

Cozen O'Connor Public Strategies said Monday it hired Meagan Foster, who was a top aide to Sen. Peter Welch, D-Vt., in its federal government affairs team.

Foster launched her federal government career 15 years ago, working as a legislative assistant in the office of then-Sen. Mark Begich, D-Alaska. Her other experience includes working for Sen. Tom Udall, D-N.M., and for the NTCA – Rural Broadband Association and the U.S. Telecom Association.

She joined Welch's office in 2020, when he was in the U.S. House of Representatives. She served as his legislative director and deputy chief of staff.
