In addition to spending the last seven years with Kirkland — five of them as a partner — he previously spent three years with Morrison & Foerster in Tokyo and three years at Weil Gotshal & Manges in New York, he said.

In addition, he said, he will advise clients in connection with IP portfolio management and adversarial patent licensing negotiations, and opinion work regarding noninfringement and invalidity.

Gearing derived broad technical experience from his six years of graduate study at the Massachusetts Institute of Technology, where he concentrated on mechanical engineering and material science, as well as from more than a dozen years he spent working as an IP litigator, he said.

"The technical subject matter of my cases has ranged across a number of industries, including cancer fighting drugs, horticulture, semiconductor design and manufacturing, microprocessor design, wireless

communications, and networking equipment and architecture," Gearing said. "My principal clients have in recent years been in the networking equipment and architecture space, but my broad technical expertise allows me to tackle basically any technical subject matter. I have also been focused more recently on IP issues arising in the blockchain, augmented reality and artificial intelligence spaces."

He earned his law degree from the University of California Berkeley School of Law and his undergraduate degree from the University of Maryland. He also holds a Ph.D. in mechanical engineering from MIT.

"Brian has a stellar international reputation as a seasoned IP litigator who naturally complements our robust intellectual property practice," Jeffrey D. Sanok, who chairs the firm's IP practice, said in a statement. "His experience will allow us to enhance relationships in Southeast Asia — a critical area of the world for us."
