The USA is Britain's largest single market. \$57bn worth of UK goods were exported to the USA in 2007, where they have traditionally been known for their high quality. The USA is also a leading destination for British overseas investment.

Despite a decrease in GDP in 2009, it is expected that the US economy will have positive growth of approximately 2.7% in 2010. The US government has created the American Recovery and Reinvestment Act (ARRA), also known as the 'Fiscal Stimulus package' worth \$787bn, aimed at encouraging growth and jump starting the US economy. This has created significant opportunities in the market.

The most prominent opportunities lie in the following sectors:

- **Infrastructure and Science:** highways, bridges, mass transportation systems, railroads and water
- **Energy:** 'green' technologies focused on reducing carbon emissions
- **Education:** improving and modernising schools
- **Healthcare:** building and modernising community health centres, and IT related to healthcare
- **ICT:** broadband infrastructure
- **Homeland Technologies:** security and communications
