

## Health Hires: Carlton Fields, Crowell & Moring, GCs

*Law360 (September 28, 2018, 9:46 PM EDT)* -- University Hospital in Newark, New Jersey, has nabbed a chief legal officer from the governor's office, Carlton Fields has brought on a health care transactional attorney from Smith Hulse & Busey, Crowell & Moring LLP has added to its intellectual property team in Brussels, and TriSalus Life Sciences has named a new general counsel from Katten & Temple LLP.

### University Hospital

Mary K. E. Maples has left her most recent role as deputy chief counsel to New Jersey Gov. Phil Murphy to join University Hospital as its chief legal officer.

Maples spent 11 years with the CIA, largely as assistant general counsel, before going to the governor's office to work with then-Gov. Chris Christie. At the CIA, her focus included high-profile congressional investigations and support for counter-terrorism litigation teams pursuing military commissions of high-value detainees, including the perpetrators of the World Trade Center attacks in September 2001 and the USS Cole attack October 2000.

Once Murphy took over for Christie, Maples was named to lead the authorities unit, representing the office before various boards, commissions and corporations, including her new employer.

At the hospital, she will lead internal and external investigations; supervise the chief compliance officer, the Office of Ethics and Compliance and the Office of the Board of Directors; and serve as the board secretary. The hospital also said she'll focus on meeting its diversity goals.

Maples is replacing Paul Matey, who is now at Lowenstein Sandler LLP.

"We are delighted to welcome Mary to our management team," University Hospital president and CEO John Kastanis said in a statement. "Having served in senior roles in both federal and state government, Mary's leadership, knowledge, and experience will be valuable assets to our entire organization."
